By remembering University College in your will, you will be supporting our mission to provide our talented and diverse students with a superb environment for learning.


Legacies help us to:

WHY LEAVE A GIFT IN YOUR WILL TO UNIV?

Unrestricted legacies support all aspects of College life. Whether our students go on to address inequalities of opportunity or become leaders in solving the challenges facing our world, your legacy gift will have lasting and far-reaching benefits.

Legacy gifts keep on giving, long into the future. By pledging a legacy gift, you are enabling Univ to plan ahead and become more financially sustainable.

Legacy gifts are tax free. A legacy gift to University College is free of tax and may reduce the inheritance tax liabilities on your estate.

Non-monetary gifts. If you would like to leave non-monetary gifts, for example shares or items of property, we would be grateful if you could discuss these with the College in advance.

We understand that the contents of your will are a private matter:

However, should you wish to let us know of your intention to leave a gift to Univ, we would be delighted, as we would then be able to thank you for your kind support.

To show our appreciation, we invite those who have pledged a gift in their will to join our William of Durham Club.

Members are invited each year to a luncheon with the Master in College, with a guest speaker; and a concert or a performance by the Univ Players. It is a popular event, often attended by current and Emeritus Fellows as well as Old Members and friends.



MAKING YOUR PLEDGE

After providing for your family and friends, it is possible to leave to Univ either a capital amount (pecuniary gift) or a share of the residue of your estate (residuary gift). Please note that an advantage of a residuary legacy is that its value will not be eroded by inflation. Whether £1,000 or £100,000, or from 1% of your estate to 100%, your legacy gift will make a significant difference.

Once you have included a legacy gift in your will, you can let the College know by emailing us at legacies@univ.ox.ac.uk or call us on +44 (0)1865 276 958. We will then be in touch to check that you have everything you need, and – if you wish – to discuss your legacy in more detail.

We suggest using the following wording in your will:

I bequeath to the Master and Fellows of the College of the Great Hall of the University commonly called University College in the University of Oxford (Registered Charity Number 1141259) [the residue of my estate] / [_____ % of the residue of my estate] / [the sum of £ _____] free of tax for the general

purposes of the College and I further direct that full receipt of the Bursar or other authorised officer of the College shall be a full and sufficient discharge to my Executors and Trustees.

By making your gift unrestricted, you will provide the College with maximum flexibility to use the funds as it sees fit at the time.

Planned giving for USA residents

Old Members and friends of the College in the United States who wish to leave a gift in their will may do so through the College directly, or through AFUCO (American Friends of University College, Oxford), in consultation with their solicitors.

AFUCO is a registered 501(c)(3) tax-exempt organisation under the Internal Revenue Code and can manage living and legacy donations from US residents on behalf of the College.

YOUR LEGACY AND TAX

Legacies can benefit your estate as well as the College.

- A legacy gift to a charity such as University College is exempt from Inheritance and Capital Gains Tax in the UK. University College has charitable status under the Second Schedule to the Charities Act 1993.
- If you leave at least 10% of your taxable estate to charity, the Inheritance Tax rate for the rest of your estate may decrease from 40% to 36%. In effect, you may be able to leave more to charity while reducing the impact on your loved ones' inheritance. Please visit www.gov.uk/inheritance-tax-reduced-rate-calculator to find out more.

MAKE A WILL ONLINE

We have partnered with an organisation called "Make A Will Online" to offer all UK-based Univ Old Members access to an online will-writing service. Making your will online through the portal is easy and substantially discounted (£60 per will) and every will is checked by a fully qualified UK solicitor. When you use our will service with "Make a Will Online", you will also be given access to Capacity Vault through the platform, free of charge. Please see the "Make A Will Online" web pages for details of this service.

Make a will face to face

If you already have a solicitor or if you would rather speak to a solicitor face to face, you should, of course, do so. Also, if you have a large estate above the Inheritance Tax threshold (see the guide to inheritance tax on www.moneyhelper.org.uk), or if you have a complex estate (e.g. trusts or foreign assets) you should also speak with a solicitor. You can find one here using the Law Society website (<https://solicitors.lawsociety.org.uk/>). And finally, where there is any worry related to testamentary capacity, we always suggest speaking with a solicitor face to face.

When you discuss your bequest to Univ with your solicitor, please ensure you use these details:
